2. I understand that I must enroll in at least 12 units for a bachelor's program, 9 units for a master's program, or 8 units for a doctoral program by the first day of the term. I understand that I must enroll in and maintain the full course of study required by Kernel University and applicable F-1 regulation. Any reduced course load must be authorized in advance by a DSO as permitted by law.
3. I understand that dropping below the required course load without prior authorization may violate F-1 status requirements. A violation may be reported in SEVIS, my SEVIS record may be terminated, and I may be required to leave the United States.
4. I will notify the school within 10 days of any change to my address, telephone number, major, or school. Failure to report a required change may result in termination of my SEVIS record.
5. Before traveling, I will make an appointment with an International Student Advisor to obtain a travel endorsement in the designated section of Form I-20.
6. I understand that failure to meet the applicable study and attendance requirements may result in dismissal and termination of my SEVIS record, subject to the University's refund policy and applicable law. If my SEVIS record is terminated, I must take immediate action to address my immigration status.
